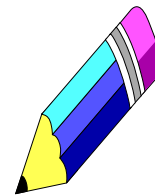


**CAMPAIGN FINANCE CHECKLIST FOR 2010 LEGISLATIVE
AND STATEWIDE CONSTITUTIONAL OFFICE CANDIDATES
APPLYING FOR A GRANT FROM THE
WISCONSIN ELECTION CAMPAIGN FUND**



Campaign Finance Reports may be submitted to the Government Accountability Board, Ethics and Accountability Division electronically (<http://cfis.wi.gov>), by mail (P.O. Box 7984, Madison, WI 53707-7984), or in person (212 E. Washington Avenue, 3rd Floor, Madison, WI).

- ☐ Obtain a copy of the **Information and Instruction Manual for Candidates Applying for a Grant from the Wisconsin Election Campaign Fund** and carefully review it with your treasurer.
- ☐ Complete and submit an **Application for Grant from the Wisconsin Election Campaign Fund (Form GAB-23)** to the Ethics and Accountability Division, no later than the deadline for filing nomination papers (**July 13, 2010**). This application can be withdrawn up until September 21, 2010.
- ☐ Complete and submit a **July Continuing Campaign Finance Report (Form GAB-24)** to the Ethics and Accountability Division no later than **July 20, 2010**, if a continuing committee or if registered before June 30, 2010. This report covers activity from January 1, 2010, or the date of registration (whichever is later) through June 30, 2010.
- ☐ Complete and submit a **Pre-Primary Campaign Finance Report (Form GAB-24)** to the Ethics and Accountability Division no later than **September 7, 2010**. This report covers activity from July 1, 2010, through August 30, 2010.
- ☐ Complete and submit a **Special Report of Late Contribution (Form GAB-3)** to the Ethics and Accountability Division within 24 hours of the receipt of a contribution or cumulative contributions of \$500 or more from a single contributor which is received from August 31, 2010, through September 13, 2010.
- ☐ Complete and submit a **Supplemental Campaign Finance Report** to the Ethics and Accountability Division no later than **September 21, 2010**, if required.
- ☐ Complete and submit a **Pre-Election Campaign Finance Report (Form GAB-24)** to the Ethics and Accountability Division no later than **October 25, 2010**. This report covers activity from August 31, 2010, through October 18, 2010.
- ☐ Complete and submit a **Special Report of Late Contribution (Form GAB-3)** to the Ethics and Accountability Division within 24 hours of receipt of a contribution or cumulative contributions of \$500 or more from a single contributor which is received from October 19, 2010, through November 1, 2010.
- ☐ Complete and submit a **January Continuing Campaign Finance Report (Form GAB-24)** to the Ethics and Accountability Division no later than **January 31, 2011**. This report covers activity from October 19, 2010, through December 31, 2010.
- ☐ Complete and submit a **Use of Grant Report (Form GAB-25)** to the Ethics and Accountability Division no later than **January 31, 2011**. This report must include proof of purchase for all expenditures paid using WECF grant funds.
